The Deuel County Commissioners met in regular session on Tuesday December 20 at 10:00 a.m. in the Commission Room of the Courthouse with Chairman Hunt presiding. Those present were Commissioners Anderson, Hanson, Jaeger, Van Liere and Hunt. Also present was Auditor Pam Lynde.

**Approval of Agenda** 1) Van Liere moved, seconded by Hanson to approve the agenda as presented. All voted yes and the motion carried.

##### **10:05 Jamie Hintz Highway Superintendent**

Hintz discussed several highway related matters with the Commissioners. Hintz said they have been busy keeping county roads open due to heavy snow and have been using more salt sand than usual because of the slippery road conditions.

##### **10:15 Sheriff David Solem**

Solem met with the Commissioners to discuss the possible purchase of a new copier for the Sheriff's Office. He presented several quotes. Colored \$5460.00; Black and white \$3236.00; Toshiba 2355 Black & white; quotes are from Office Peeps. 2) Hanson moved, seconded by Anderson to approve the purchase of a Toshiba 3-Studio 255 copier at cost of \$3236.00 from Office Peeps.
