 - a. Variance Requested: Section 1103.06 – Minimum Lot Area and Yard. Applicant/Owner Scott Keigh requests permission to remove an existing deck and construct a new deck, pergola, and fire pit wall. The deck, pergola, and fire pit wall are within the 10-foot side-yard setback requirement, and the pergola and fire pit wall are within the 50-foot high-water mark setback requirement. The property is located on Lot 7 and Lot 7A, In Replat of Lot 10, Ingvalsons Sugar Sand Beach Addition, Norden Township, Lake Cochrane, Deuel County, South Dakota
 - b. Variance request to Section 1219.03 Setbacks: gravel or quarry operation, mineral exploration and extraction, rock crushers within 1000 feet from property line of nearest residence. The applicant, Rogge Excavation Inc, property owner, Todd & Jody Jongeling are requesting to operation, mineral exploration and extraction, rock crusher, concrete and asphalt mixing plants. Property is located in SW1/4 Less Outlots 1-2 & Less Thompson Air Strip in Section 18-113-50, Grange Township, Deuel County, South Dakota.
 - c. Conditional Uses Permit Pursuant to Section 1101.04.04 Sand, gravel or quarry operation, Mineral exploration and extraction, rock crushers, concrete and asphalt mixing plants provided they they meet requirements of Section 1219. The applicant, Rogge Excavation Inc, property owner, Todd & Jody Jongeling are requesting to operation, mineral exploration and extraction and rock crusher. Property is located in SW1/4 Less Outlots 1-2 & Less Thompson Air Strip in Section 18-113-50, Grange Township, Deuel County, South Dakota.
 - d. Variance request to Section 1101.05.02 Area Regulations – Front Yard. The applicants/owners, Ron and Kathy Gorder, are requesting a variance to build a Hoop Barn (to be used for a Class D CAFO, which is a permitted use) in the Agricultural District within 65 feet of the road right-of-way. Property is located in E286.96' W630.96' S624.36' in SE1/4 Less That Portion of Block 1 Bahr Addition in the Section 11-113-50, Grange Township, Deuel County, South Dakota
