August 1st, 2023 Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, August 1st at 9:00 A.M. in the Commission Room of the Courthouse with Chairperson Homan presiding. Those present were Commissioners Steve Rhody, Scott Fieber, Judith Homan, Jay Grabow and Harry Mewherter. Also present was Deputy Auditor Pam Lynde. The meeting opened with prayer and the pledge of allegiance. 1) Fieber moved, seconded by Grabow to approve the agenda as presented. All voted yes and the motion carried. 2) Grabow moved, seconded by Rhody to approve the regular meeting minutes of July 6 and 18 and special meeting of July 25. All voted yes and the motion carried.

# **APPOINTMENTS**

# 9:00 Highway Superintendent Jamie Broksieck

Broksieck presented an application for Right of Way Occupancy from Sioux Valley Energy along Highway 313 in section 25, 35, 36 113N 50 W project WO #33350 overhead electric distribution that is one mile south of Hwy 28 and eventually will end up in Brookings County. 3) Rhody moved, seconded by Mewherter to approve and sign the Right of Way Occupancy application of Sioux Valley Energy. All voted yes and the motion carried. Broksieck said chip sealing has been done; junk pile cleaned up and crushed what they could. Waylon Blasius engineer with Banner was present and presented pay application #3 for the Haul Road Restoration Project. He stated that he had still retained the asphalt removal and 1200 tons of the asphalt placed to account for those areas on the project. Blasius said that the total project retainage had been reduced from 5% to 1.5% since the road is open for use and that \$77,00 plus the retained asphalt and asphalt removal still adds up to approximately \$200,000. Blasius said he had met with project manager to go through punch list; some asphalt areas need to be addressed; the shoulders were addressed and they will be working on that; box culvert still needs to be completed. 4) Grabow moved, seconded by Fieber to approve pay application #3 to Duininck Inc in the amount of \$1,793,496.97 as submitted. All voted yes and the motion carried. Broksieck said they will be starting on bridge replacement on highway 375 next week which is a BIG grant project.

## 9:30 Executive Session Pursuant to SDCL 1-25-2-(1) Personnel Matter

5) Grabow moved, seconded by Fieber to move into Executive Session pursuant to SDCL 1-25-2(1) to discuss a personnel matter. All voted yes and the motion carried. Chairperson Homan declared the Commissioners out of Executive Session at 9:55 a.m.

# 10:00 Veteran Service Officer Dennis Evenson

Evenson presented the invoice for renewal of the VetraSpect Program in the amount of 449.00; This program is used to help veterans and their families. He also requested payment of travel expenses for the annual training in Pierre at end of August that is required for Veteran Service Officers. 6) Mewherter moved, seconded by Grabow to approve the payment of VetraSpect program and travel expense to attend the workshop in Pierre. All voted yes and motion carried.

## 10:15 Public Hearing and Joint Meeting with Zoning Board

The Zoning Board and County Commissioners held a public hearing on revisions to the Deuel County Zoning Ordinance. Zoning Board members present were Dennis Kanengieter, Mike Dahl, Kevin DeBoer, Paul Brandt and Jay Grabow. The Boards met

jointly to hold a public hearing on several updates and corrections to the current zoning ordinance.

Ordinance #B2022-01-04, An Ordinance to amend Article XI, "Zoning Districts," Section 1103 "LP" Lake Park, Section 1103.04.

- 19. Private storage facilities provided they meet the requirements of Section 1245; Conditional Uses, Article XI, "Zoning Districts," Section 1103 "LP" Lake Park District, Section 1103.07. Shoreline Stabilization, Filling, Grading, Lagooning and Dredging,
  - i. Approval from adjoining <u>lake-front</u> property owners

Article XII, "GENERAL REGULATIONS" Section 1236.02 Modular Homes,

b. Modular homes will include all <u>prefab</u> off-site constructed homes, which may be transported to the site in-one or more sections. <u>multiple sections called modules and put</u> together on site by your builder.

Article XI, "Zoning Districts" Section 1101. "A" Agricultural District, Section 1101.02 Permitted Uses,

3. Site-built single-family residences; and moved in single-family residences provided that they meet the requirements of Section 1205

Section 1103. "LP" Lake-park District, Section 1103.03 Permitted Uses, Section 1106.

1. Site-built single-family residences usage; and moved in single-family residences provided that they meet the requirements of Section 1205

"TD" Town District, Section 1106.02 Permitted Uses, Section 1101 "A" Agriculture District, Section 1101.05

1. Single-family residential usage, including Type A and Type B Manufactured Homes, provided that provisions of Section 1236 are met. Also including moved in single-family residences provided that they meet the requirements of Section 1205

Article XII, "GENERAL REGULATIONS" Section 1238 Accessory Buildings Table 1238-1

1.c. Unattached garages shall be limited to maximum sidewalls of fourteen (14) feet; and a maximum minimum of 4/12 roof pitch or to conform to the design of the house.

2. Buildings or structures for customary residential storage purposes not over ten (10) feet in height and not exceeding one hundred fifty (150) two hundred forty (240) square feet in gross floor area with a door opening no wider than seven (7) feet.

Article XI, "Zoning Districts," Section 1101 "A" Agriculture District, Section 1101.05 Area Regulations

1. Lot Size: All residential lots shall be a minimum of three (3) acres, except as provided in item 7 <u>6</u> below. All other permitted uses and conditional use permits shall have a minimum area and setback regulations as determined by the Board of Adjustment.

Article XIII, "Concentrated Animal Feeding Operations Regulations," Section 1303. Concentrated Animal Feeding Operation Permit Requirements

8. Notwithstanding 1103.4 1303.4 (above) a change in ownership of a Class A or Class B concentrated animal feeding operation which does not have a previously issued county-permit.

Article XIII, "Concentrated Animal Feeding Operations Regulations," Section 1304. Concentrated Animal Feeding Operation Control Requirements

New Class A, B, C, and D (with more than five hundred (500) animal units) Concentrated Animal Feeding Operations shall dispose of dead animals, manure and wastewater in such a manner as to control odors or flies. A management plan is required for submission of a permit. The Zoning Officer and/or Board of Adjustment will review the need for control measures on a site-specific basis, The following procedures to control flies and odors shall be considered in a management control plan:

New Class A, B, C, and D Concentrated Animal Feeding Operations shall dispose of dead animals, manure and wastewater in such a manner as to control odors or flies. A management plan is required for submission of a permit. The Zoning Officer and/or Board of Adjustment will review the need for control measures on a site-specific basis. The following procedures to control flies and odors shall be considered in a management control plan:

Article XII, "GENERAL REGULATIONS" Section 1208 Shelterbelt Setback Requirements,

7. Shade trees, ornamental trees or shrubs generally used for landscaping and windbreak are allowed in a controlled area. The controlled area is defined as the area within one hundred (100) feet of homes or farm buildings, but not closer to the right-of-way than fifty (50) feet. Except for the following, plantings within the controlled area are exempt from this regulation. Four-Six or more trees in a row are not allowed with the controlled area. Deciduous trees which are spotted or staggered within the controlled area can be no closer than twenty (20) feet. Conifer trees which are spotted or staggered within the controlled area can be no closer than twenty-five (25) feet. The distance between trees shall be determined by measuring distance between tree trunks. See Figure 1208.3.

Kanengieter chaired the public hearing and began by asking Theisen to provide an overview of the proposed ordinance. Theisen stated that the Planning Commission had been working on the comprehensive review of the zoning ordinance for a couple of years, with public hearings on September 28 and November 15 of 2022. There were some oversights and cleanup with some advertent mistakes that were found which were provided to each board member. Theisen also stated there were some scrivener's errors. Kanengieter and Homan each closed the public hearing for their respective boards. Kanengieter asked for a motion and a second to recommend approval of Ordinance #B2022-01-04 to the Board of County Commissioners. Motion by Dahl, Seconded by

Kanengieter and the motion passed unanimously.

The County Commission then held the first reading of ordinance #B2022-01-04, as amended by the Planning Commission, by title. Homan asked Theisen to conduct first reading.

7) Grabow moved, seconded by Rhody to hold the second reading of the proposed ordinance on August 15, 2023 at 10:15 a.m. All voted yes, Motion carried.

Theisen presented one plat to the board. 8) Rhody moved, seconded by Grabow to approve plat of "Peterson Addition Located in the Southwest Quarter Section 32, Township 114 North, Range 48 West of the 5<sup>th</sup> P.M., Deuel County, South Dakota" and Resolution 23-26. All voted yes and motion carried.
