October 3, 2023 Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, October 3 at 9:00 A.M. in the Commission Room of the Courthouse with Chairperson Homan presiding. Those present were Commissioners Steve Rhody, Scott Fieber, Judith Homan, Jay Grabow and Harry Mewherter. Also present was Deputy Auditor Pam Lynde. The meeting opened with prayer and the pledge of allegiance. 1) Fieber moved, seconded by Mewherter to approve the agenda as presented with the addition of discussion of Zoning Ordinance and transfer from Contingency to 4-H and Fire Rescue. All voted yes and the motion carried. 2) Grabow moved, seconded by Fieber to approve the regular meeting minutes of September 6 and 19. All voted yes and the motion carried.

APPOINTMENTS

9:00 Highway Superintendent Jamie Broksieck

Broksieck met with the Commissioners and presented several items for discussion. He said they are half done with mowing; bridge near Winrow's is complete; Norden Twp needs a snow wing post and the County has one that came from a blade that was sold earlier to someone overseas and they didn't want the snow wing so it was declared surplus when the blade was sold. Broksieck will discuss with the township the possibility of purchasing this piece from the County.

RESOLUTION #23-28

A RESOLUTION ADOPTING THE DEUEL COUNTY FIVE-YEAR HIGHWAY AND BRIDGE IMPROVEMENT PLAN

WHEREAS, the South Dakota Department of Transportation Local Bridge and Improvement Grant Fund requires that in order to be eligible to apply for Bridge Improvement Grant funds, Counties are required to develop a five-year Highway and Bridge Improvement Plan, hereinafter referred to as Plan;

and

WHEREAS, Deuel County has utilized the South Dakota Department of Transportation, County Staff, the First District Association of Local Governments, Townships, and the general public in developing the various components of the Plan; and

WHEREAS, the Plan includes maps and lists identifying an inventory of highways and bridges, project needs, and revenue sources; and

WHEREAS, Deuel County held a public meeting on September 19th, 2023 to solicit input into the Plan, and the citizens who attended expressed an interest in the Plan; and

WHEREAS, the County will be able to use the Plan as a tool to budget for transportation enhancements and better coordinate transportation issues with other entities;

NOW, THEREFORE, BE IT RESOLVED BY THE DEUEL COUNTY BOARD OF COUNTY COMMISSIONERS THAT THE DEUEL COUNTY FIVE-YEAR HIGHWAY AND BRIDGE IMPROVEMENT PLAN IS HEREBY ADOPTED AND IS RECOGNIZED AS THE HIGHWAY AND BRIDGE IMPROVEMENT PLAN FOR DEUELCOUNTY.

9:30 Weed Supervisor Keith Goens-Travel Request

Goens said he attended and worked at the SD State Fair Sept. 1 and 3 and requested reimbursement for mileage. 10:00 Community Health Nurse Tammy Baer-Health Nurse Contract 23-24

Baer and Allison Nelson met with the Commissioners to discuss the 23-24 Health Nurse Contract. Baer said it is a very workable partnership, all sharing the same costs; Nelson said it has been about a break-even contract. The state requested a 3% increase from the previous year. 5) Mewherter moved, seconded by Rhody to approve and sign the Public Health Nurse Contract between the State Dept of Health, Sanford Health and the County for FY 2023 in the amount of \$38384. All voted yes and the motion carried.

10:15 Eric Kunzweiler-ICAP Updates

Kunzweiler met with the Commissioners and discussed updates and changes to InterLakes Community Action Programs. He stated that he took over as the CEO two years ago and comes to Commission meetings to become more familiar with the counties and to give updates on programs; Miriam Reppe is local Service Worker; each county has different services that they can provide; Emergency Rental assistance is a big one in this county; recipients must meet criteria; 80% of Ami and provide adjusted media income; provide financial impact Covid has had on them; will end in 2025. The board has been downsized to a board of 15; 14 counties into 5 regions and Deuel is in Region One; ICAP block grant is over a million dollars a year. Kunzweiler thanked the county for their support.

10:30 Executive Session Pursuant to SDCL 1-25-2 (1) Personnel Matter

6) Grabow moved, seconded Mewherter by to move into Executive Session for a personnel matter. All voted yes and motion carried. Chairperson Homan declared the Commission out of Executive Session at 10:45.

Sheriff Cory Borg also met with the Commissioners and talked about the purchase of a vehicle for next year. He said the state bid list is out for next year; he talked about what would be the best option next year; he said a vehicle will be hard to get; he feels an SUV would be the best option; he said the County will have to order soon if off the state bid. Borg said now they have seven patrol cars; keep one as a spare in case one is down or they have a long transport; He said that he should have more concrete numbers for next meeting.

Commissioner Rhody gave a report from the SD County Convention.
