November 7, 2023 Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, November 7 at 9:00 A.M. in the Commission Room of the Courthouse with Chairperson Homan presiding. Those present were Commissioners Steve Rhody, Scott Fieber, Judith Homan, Jay Grabow and Harry Mewherter. Also present was Deputy Auditor Pam Lynde. The meeting opened with prayer and the pledge of allegiance. 1) Fieber moved, seconded by Mewherter to approve the agenda with the addition of Global Dairy spill. All voted yes and the motion carried. 2) Rhody moved, seconded by Mewherter to approve the regular meeting minutes of October 3 and 17. All voted yes and the motion carried.

APPOINTMENTS

9:00 Highway Superintendent Jamie Broksieck

Broksieck met with the Commissioners and presented several items for discussion. He asked to go into Executive Session SDCL 1-25-2(3) to discuss a contractual matter. 3) Fieber moved, seconded by Rhody to move into Executive Session at 9:05 to discuss contractual matter with legal counsel. All voted yes and motion carried. Chairperson Homan declared the Commission out of Executive Session at 9:30 a.m.

Discussion was held on a letter received by Banner Associates from Duininck Contracting concerning the Deuel County Haul Road Restoration project. Those present on behalf of Duinick were Justin Zylstra and Kyle Hant of Fabyanske Law Firm. Also present was Waylon Blasius of Banner Associates, engineer for Deuel County on the project. A letter from Duininck to Banner Associates, engineering firm for the project, said that Duininck Inc. and their subcontractors faced many challenges with the existing roadway subgrade failing under construction traffic. Duininck said they had attempted multiple different means and methods to minimize these failures but were unavoidable and all of the identified failing subgrade areas were dug out and filled with base course material and separated with fabric, including areas already paved. The county doesn't feel they should have to pay for the asphalt pavement that was replaced resulting from these dig outs. In a Geotek report it stated that the subgrade conditions varied from poor to favorable. Duininck Inc. said in the letter they had no design responsibility and will not be liable for conditions outside the contract. Ultimately Duininck is looking for payment in the amount of \$378,725.90, which doesn't include payment due to DeBoer Const. for asphalt pavement removal done in preparation for the asphalt patching over failed subgrade areas. Plus, Duininck said they have more costs due to subgrade failures that they will be claiming which amounted to \$24,000. At the meeting Zylstra said they are looking to be reimbursed for losses beyond their control; sub grade started to fail under construction traffic. Zylstra felt the issues changed operations; subgrade moving because of traffic and weight on road; not result of their operation. Commissioner Grabow asked if starting construction before frost was out of ground was part of the problem and Zylstra said they didn't start construction too early. He said the dig outs didn't include removing failed asphalt so the extra amount of \$53,150 from DeBoer. Movement became necessary because of subgrade of road according to Zylstra; felt this was the best method to get it done according to contract. Kyle Hant, construction attorney for Duininck, spoke and said they are not design experts and Duininck bid project but because of

subgrade said it is not their fault as the contractor. State's attorney Evenson said Geotek is not part of the contract documents; responsibility is to build the road not design the road; everything was blamed on the subgrade and the County believes there is a fault in construction.

Waylon Blasius of Banner Associates presented a narrative and additional comments concerning Duininck Inc's claim letter for additional compensation. He recommended that the County remain focused on the Construction Documents and Construction Contract. He said Duinick is asking for an additional \$456,784.36 which includes \$24,000 for incidentals and \$53,150 to DeBoer Construction and \$378,725.90 for additional work done. The discussion ended at 9:55 with plans to discuss again at a future meeting.

The change order for Box Culvert Project 20-200-163 PCN 09 GY and final billing of Lehtola Builders was presented. 4) Rhody moved, seconded by Fieber to approve and sign change order number 1 with contractor Lehtola Builders, Inc. from original price of \$927,777.36 to \$916,196.32 and pay final payment to Lehtola Builders, Inc. in the amount of \$236,987.91 for Project 20-200-163. All voted yes and motion carried.

Global Dairy was present at the meeting to discuss a manure spill that happened last weekend; Arjan Blok of Global Dairy stated neighbors were concerned and he contacted the DNR Sat. morning concerning the spill and have taken measures so this will not happen again as they want to keep the dairy clean and well managed and be a good neighbor.

9:45 4-H Advisor Deb Lessman-4-H Year in Review; Fence at Fairgrounds

Lessman gave a report of the 4-H activities this year. She presented a snap shot of the 4-H program for the year; social skill development; life skill development, work force development and leadership development. Lessman said the fence at 4-H grounds needs to be repaired or replaced and is seeking quotes for that to be done. The 4-H recognition event went well with over 60 participants.

10:00 Sheriff Cory Borg - City Police Contracts

Borg discussed the 2024 city police contracts with towns in the county. 5) Grabow moved, seconded by Fieber to approve contracts with Gary, Toronto and Clear Lake for 2024 with contract price being \$40 an hour. All voted yes and motion carried. 10:30 Executive Session Pursuant to SDCL 1-25-2 (1) Personnel Matter

6) Grabow moved, seconded Mewherter by to move into Executive Session for a personnel matter. All voted yes and motion carried. Chairperson Homan declared the Commission out of Executive Session at 10:45. 7) Rhody moved, seconded by Fieber to give additional compensation to Pam Lynde for work in the Auditor's office. All voted yes and motion carried.
