All voted yes and motion carried. Several townships have submitted improvement plans for the 23-24 RAIF grant cycle. Applications for improvement projects are due October 31. Work is progressing well on the BIG grant bridge replacement project.

9:15 Mark Junker-Banner Associates-2023 Bridge Inspection Report

Junker presented the 2023 Bridge Inspection Overview a federal requirement that bridges be inspected every 2 years with SDDOT paying 80% of inspection costs the County pays 20%. Any bridge with opening of 20' or more must be inspected. 40 bridges on inspection list with half inspected each year; 9 in poor condition; 16 fair condition and 15 good condition; 8 bridges have weight limit restrictions; Future Bridge Needs: Replace 3 bridges in next 10 years, 1 on gravel and 2 on township roads; Future Preservation Needs: 1 project on county asphalt; 4 riprap projects in next 10 years all on county asphalt; SD BIG preservation -80-20; Recommendations: Install new load posting; Priority replacement; Preservation project; Riprap projects; Preventative maintenance; stabilize erosion. Junker said the job of the engineering firm and the County is to protect the public safety. He encouraged the county to continue to invest in the bridge system through BIG program and local federal funding and local funding.

10:00 Budget hearing 2024 Provision Budget

The scheduled public hearing for the 2024 budget was held. Nicole Klein from the Deubrook Library was present and requested \$700 in funding for the summer library reading program in Toronto for the Deubrook Community Library. Nancy Hartenhoff Crooks, library board member was also present; Community access in Toronto; it is not just a school library but community library; great increase in kids using Toronto program; elementary teacher in Toronto is running the program in Toronto; they requested \$700 be included in the 24-county budget to help with the reading program.

The 2023 certified utility values for Deuel County were received from the state Dept. of Revenue and are \$95,216,381 less discretionary values of \$26,294,420 due to Ottertail Power and NorthWestern Corp qualifying for the formula under SDCL 10-6-37 and County Resolution #20-20, bringing the valuation for utilities to \$68,928,149 with the total county valuation being \$1,059,353,328. Several modifications to the budget were heard and discussed. Tax levies along with growth factors are being figured and the proposed 2024 budget with any changes will be adopted at the September 19 meeting.

10:45 Keith Goens-Weed Dept. Update

Goens presented an update of the Weed Dept. activities. All state roads done and county roads sprayed; and did many township roads. He will pursue an estimate for a truck and bring back to a future meeting.
