The applicant, 212 Works LLC, property owners, Bradley & Martie Bothun, would like to operate a seasonal fireworks stand on their property described as That part of the W1/2SW1/4 of Section 15-117-47 being also described as Gov Lot 1 in said Section, which lies south of HWY 212, except Highway right-of-way, Antelope Valley Township, Deuel County, South Dakota.
