

September 20, 2022
Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, September 20 at 9:00 a.m. in the Commission Room of the Courthouse with Chairman Homan presiding. Those present were Commissioners Gary DeJong, Gary Jaeger, Steve Rhody and Judith Homan. Roger Kreutner was absent. Also present was Auditor Pam Lynde, Jay Grabow and Scott Fieber. The meeting began with prayer and the Pledge of Allegiance and was then called to order.

Approval of Agenda

1) Rhody moved, seconded by DeJong to approve the agenda as presented with addition of amend minutes of Sept. 7. All voted yes and the motion carried. 2) DeJong moved, seconded by Jaeger to amend minutes of Sept. 7 third paragraph under Appointments Highway, after County road strike 1 and add 305 and 513 on 175th St. All voted yes and motion carried.

APPOINTMENTS

9:00 Highway Superintendent Jamie Broksieck

Broksieck met with the Commissioners and presented several highway department updates.

Broksieck requested the purchase of a used Shouldering Paver #HR3015 from Star Equipment LTD at a cost of \$14,915.00. 3) DeJong moved, seconded by Rhody to approve purchase of Shouldering Paver #HR3015 from Star Equipment LTD at cost of \$14,915.00. All voted yes and motion carried. He said they will be starting BIG project 108-200 ¾ E on 166th St from Hwy 15; they started mowing ditches on Monday.

Broksieck talked about the small structure inventory for rural access infrastructure improvement for townships. Townships must have a five year road and bridge plan; information due to County by August 31; Oct. 31 must have grant application submitted; Jan. 15 is deadline for Commissioners to award grants. He said the Commissioners must adopt guidelines for applications and grant process.

9:15 Mark Junker Banner Associates-Bridge Inspection Results 2022

Junker presented the 2022 Bridge Inspection Overview a federal requirement that bridges be inspected every 2 years with SDDOT paying 80% of inspection costs the County pays 20%. 40 bridges on inspection list with half inspected each year; 8 bridges have weight limit restricts; 13 bridges replaced since 2000; Future Bridge Needs: currently 12 bridges need replacement in the next couple decades; Future Preservation Needs: 1 steel girder bridge-county asphalt; 7 concrete slab bridges-all on county asphalt; SD BIG preservation -80-20; Recommendations: Repair erosion/scour; Repair Column; Future replacements bridge 0-50-273. Any bridge with opening of 20' or more must be inspected. Junker said the job of the engineering firm and the County is to protect the public safety. He encouraged the county to continue to invest in the bridge system through BIG program and local federal funding and local funding.

10:00 Public Hearing on 5 Year Highway Road and Bridge Improvement Plan

The Five Year County Highway and Bridge Improvement Plan was presented and discussed. The Plan includes a bridge inventory list and a project needs list. It also includes a revenue source table, sufficiency rating map, surface type and average daily traffic and bridge location map, rating map and the five year project location map. The plan is a short range planning tool that will be developed and updated annually based on needs and identified Deuel County transportation policies. Several township citizens attended the hearing and discussion was held on the plan. The plan, with any suggested changes will be adopted at the October 4

meeting. Broksieck said the plan hasn't changed a whole lot from the prior year's plan. Counties need to place a portion of their own funding into projects or they won't be considered. Broksieck said the plan places bridges on high priority so they are eligible for funding. Question was asked if there are state or federal funds to address the township roads. Gary Magedanz Lowe Township officer asked about potential projects to be done in 2023; Engineering on Bridge #140-006; Bridge 200-114 Preliminary Engineering Bridge Rehab.

NOW THEREFORE BE IT RESOLVED, that such provisional budget as amended and all its purposes, schedules, appropriations, amounts, estimates and all matters therein set forth, SHALL BE APPROVED AND ADOPTED AS THE ANNUAL BUDGET OF THE APPROPRIATION AND EXPENDITURES FOR DEUEL County, South Dakota and all its institutions and agencies for calendar year beginning January 1, 2023 and ending December 31, 2023 and the same is hereby approved and adopted by the Board of County Commissioners of Deuel County, South Dakota, this 20th day of September, 2022. The Annual Budget so adopted is available for public inspection during normal business hours at the office of the county auditor Deuel County, South Dakota. The accompanying taxes are levied by Deuel County for the year January 1, 2023 through December 31, 2023.

11:30 Sheriff Cory Borg-911 Repeaters; 2023 Police Contracts

Borg discussed the 911 repeaters: West Central Communications inspected repeater tower for Clear Lake, Gary, Toronto; Gary and Toronto towers checked out ok; Clear Lake duplexer was adjusted again; duplexer is using about half the power. Borg said installing another cable with another antenna on CL tower would give more range out of that tower; Clear Lake tower used by Goodwin, Clear Lake, Brandt; antenna does only analog; Approximate cost for antenna would be \$2000 plus cable and installation. Borg will check further on cost and bring back to the next meeting. Borg said they have to have the antenna for analog as all Fire Departments are on analog radios.
