May 16th, 2023 Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, May 16th, at 9:00 A.M. in the Commission Room of the Courthouse with Chairperson Homan presiding. Those present were Commissioners Scott Fieber, Judith Homan, Jay Grabow, Steve Rhody and Harry Mewherter. Also present was Auditor Courtney Parker and several members of the public. The meeting opened with prayer and the pledge of allegiance. 1) Grabow moved, seconded by Mewherter to approve the agenda with the addition of Executive Session. All voted yes and the motion carried.

### **OLD BUSINESS**

There are 11 trees that are dead around the courthouse that need to be removed. We received three quotes. State Line Tree Service \$11,500.00, TK Trees \$9,792.00 and Kevin's Tree Service Inc. \$4,840.00. 2) Grabow moved, seconded by Mewherter to approve the quote from Kevin's Tree Service Inc. in the amount of \$4,840.00 for removal of 11 trees around courthouse by June 15<sup>th</sup>, 2023. All voted yes and the motion carried. Kevin DeBoer was here from the public.

# **APPOINTMENTS**

## 9:00 Highway Superintendent Jamie Broksieck

Broksieck discussed updates he had for the board. Broksieck presented bids from the Box Culvert Project 20-200-163 bid letting held on Wednesday May 10<sup>th</sup> at 10:00 A.M. There were three bids. Prahm Construction Inc. \$1,131,112.00, BX Civil & Construction, Inc \$1,120,000.00 and Lehtola Builders, Inc \$927,777.36. SDDOT will reimburse the county for 80% of the construction costs through the BIG program. 3) Fieber moved, seconded by Grabow to approve the bid of Lethola Builders, Inc of \$927,777.36 for the Box Culvert Project 20-200-163. All voted yes and the motion carried. Banner Associates, Inc will be engineering the project. SDDOT will also reimburse the county for 80% of Banner's services. 4) Rhody moved, seconded by Grabow to approve the contract from Banner Associates, Inc for their engineering services during construction of Box Culvert Project 20-200-163. All voted yes and the motion carried. The box culvert construction project cannot proceed without Wetland Credit Payment to Tetonka, LLP. The credit payment goes towards benefiting wetlands. 5) Grabow moved, seconded by Mewherter to pay the invoice of \$32,000.00 to Tetonka, LLP for the Wetlands Functional Capacity Unit Credits Purchase Contract. All voted yes and the motion carried.

### 9:40 Deuel County 4-H Youth Advisor Deb Lessman

Lessman asked for approval of \$5,000.00 to the 4-H Leaders Association for new livestock pens at the 4-H Service Center. The \$5,000.00 was approved by the 2022 Board of Commissioners, but it was decided to run it through the 2023 Board of Commissioners to make them aware of what the money was going towards. The total cost of the pens will be around \$14,000.00. The Leader's Association will be assembling the pens and setting them up during some evenings the second week in June. The Board had no objections to the funds so the motion from the November 15<sup>th</sup>, 2022 meeting stands.

### 10:00 Public Hearing & Joint Meeting with Zoning and Planning Board

The Deuel County Zoning and Planning Board, Dennis Kanengieter, Jay Grabow, Kevin DeBoer, and Mike Dahl met, along with the Commissioners jointly to hold a public hearing on the request of petitioner/owners Jeremy and Rachelle Wipf to issue a

change in zoning classification for property that is described as NE1/4NW1/4NE1/4 & W268' N661.47' NE1/4NE1/4 in Section Twenty (28), Township 113 North, Range 47, West of the 5th P.M., (Scandinavia Township) in Deuel County, South Dakota. Containing 13.35 Acres to "AG" Agricultural District from "CI" Commercial/Industrial District. The Deuel County Zoning Board stated the property meets the necessary requirements of the ordinance. In 2020 Wipf rezoned their property to "CI" Commercial/Industrial District from "AG" Agricultural District. After some additional discussion on the matter, Deuel County Planning Commission member Dahl motioned, seconded by Grabow, to rezone the above-described property from "CI" Commercial/Industrial District to "AG" Agricultural and to waive the rezoning fee. Upon a roll call vote all Deuel County Planning Commission members voted yes and the motion carried. Motion to adjourn was made by DeBoer, second by Grabow. All voted yes and the motion carried.

The Deuel County Planning Commission then recommended to the Commissioners that the above-described property be rezoned to "AG" Agricultural. Upon the recommendation of the Zoning Board, the Commissioners then held the first reading of Ordinance B2022-01-02A. The second reading will be held at the June 6<sup>th</sup> 10:00 A.M.
