The Deuel County Commissioners met in regular session on Tuesday, December 5th at 9:00 A.M. in the Commission Room of the Courthouse with Vice Chairman Steve Rhody presiding. Those present were Commissioners Steve Rhody, Scott Fieber, Jay Grabow, Harry Mewherter, and by teleconference Judith Homan. Also present was Auditor, Courtney Parker and State's Attorney, Craig Evenson. There were many people from the public in attendance. The meeting opened with prayer and the pledge of allegiance. 1) Grabow moved, seconded by Mewherter to approve the agenda with additions of surplus scrap iron for Highway Department and Executive Session pursuant to SDCL 1-25-2 (1) personnel matters. All voted yes and the motion carried. 2) Fieber moved, seconded by Grabow to approve the minutes from November 7<sup>th</sup> and 21<sup>st</sup> as presented. All voted yes and the motion carried.

## **10:00 Public Hearing for Easement**

Discussion was had on the Zirbel property by Lake Alice in regards of public land access. Mitchell Koehn, attorney representing Steven and Monica Zirbel, explained the factual data on this easement. Prior to purchasing the land, the Zirbels contacted the Register of Deeds office to determine if the section line right of way 478<sup>th</sup> avenue north of 174<sup>th</sup> street, was vacated. The Register of Deeds could not locate any recorded document vacating the section line right of way. Jim Dailey explained that the Zirbels did in fact know, there was no access to the land. Julie Moe stated they would like to continue to develop their land but the past Zoning Board said they couldn't further develop because they had to be 700 feet from Jackson's (previous owner of Zirbel properties) land. Andrew Haas explained that he built the pens for his pheasant farms up to the section line. If the vacated section line is used for public right of way, he will have biosecurity problems causing him to cute his business in half. The Board is trying to figure out a solution for the problem. 4) Grabow moved, seconded by Rhody to meet on the 12<sup>th</sup> of December at 11:00 AM at STR 7-116-48, 1-116-49 and 12-116-49 to look at the private properties of the adjoining land owners to see which option would be best for public right of way due to the isolated properties.
