Discussion was held on the Good Samaritan Center building. Commissioner Grabow has toured the facility and said there are options for the use of the building such as assisted living and apartments. Grabow said the roof is rubber and isn't in bad shape but the seams are and could be repaired with rubber seal; some of the pipes need to be replaced. Gary Jaeger and Sarah Salzer with CLAD were at the meeting; Jaeger stated they have to take a little more time to decide what to do with the building. Grabow said on south portion there was assisted living and if left as assisted living would save on renovation and cut costs; manage the assisted living with professional agency; building is unrestricted so can put assisted living back; he also feels they need to take a little more time to decide what to do; not remodeling everything; some are concerned about possibility of asbestos; built by Deuel County residents for citizens of the county. Commissioners will continue discussion with community and DADi board members.
