

July 7, 2020  
Regular Meeting

The Deuel County Commissioners met in regular session on Tuesday, July 7 at 9:00 a.m. in the Commission Room of the Courthouse with Chairman Jaeger presiding. Those present were Commissioners Rhody, Jaeger, DeJong, Homan and Kreutner. Also present was Auditor Mary Korth and several members of the public. The meeting began with prayer and the Pledge of Allegiance.

**Approval of Agenda**

1) Rhody moved, seconded by Kreutner to approve the agenda as presented. All voted yes and the motion carried.

**Approval of Minutes:**

2) Homan moved, seconded by DeJong to approve the minutes of the regular meetings of June 4<sup>th</sup> and June 16<sup>th</sup>. All voted yes and the motion carried.

**APPOINTMENTS**

**9:00 Highway Superintendent Jamie Hintz**

Hintz met with the Commissioners to discuss several issues.

The bridge replacement in the Hidewood is going well and on schedule weather permitting. Bridge replacement in the northern part of Deuel is starting and is expected to be on schedule with success. Discussion was held on the Federal Bridge Replacement Program. Hintz thought the funds were unfairly dispersed. Many counties received no funds because their bridges were in good condition and properly maintained, other counties received bridge replacement for up to 13 bridges because of poor bridge upkeep. Many counties are upset that the disbursement was unfair. Each county could have used some funds and not just the ones that had poor bridges.

Hintz suggested that the County invest in headsets for his employees to use for communication while driving in light of the new law concerning cell phone use and operating a motor vehicle. Cell phones are used a lot for communication among highway workers. The Board thought it was a wise idea to look into headsets to be provided for the highway department.

Hintz stated the Highway Department is in need of a different pickup and has a budget line item available to purchase a different one. Hintz will be looking into different quotes to present to the Board in the future.

Hintz has been very busy with the three wind tower projects going on in the county. Dust control is an issue on township roads. Casey Magedanz and Calvin Musch were present for Portland Township and expressed concern for dust control especially in front of residences. Discussion was held among Township board members, Hintz, and the Commissioners along with a representative from Invenergy, Dan Litchfield. A separate meeting was set up for further discussion. Hintz has been receiving complaints with potholes on the roads that are proving to be dangerous. Invenergy stated they will have a paving crew in place to repair the potholes and apologized for the delay. Safety is of the utmost concern. More discussion was held among the individuals present. Discussion was held on use of roads that are not part of the haul road agreement especially with numerous heavy trucks. State's Attorney John Knight was present and stated a conference call was held to make sure the highway department gets more answers and improve communication between all entities

related to the wind tower projects. A chain of command and a communication ring was set up and has greatly improved all areas.

With all the activity in the Highway Department Hintz stated he is unable at this time to keep up on the custodial duties at the County West Building like he has been doing in the past. He has asked Deputy Auditor Brittane Collins to assist him with that in the past and is asking the Commissioners to authorize that Brittane put some more time into helping at the West building when she is available. Commissioner Homan also offered her time to step in and help the custodial duties during this busy time. Between Collins and Homan, they will assist in the duties.

Hintz is still planning for a fall retirement and once again mentioned a replacement Highway Superintendent. There was only one applicant at the time it was open which was Foreman Broksieck. The Commissioners would prefer to interview him and start the process.

Hintz is intending on holding employee evaluations soon and commended his employees on working through the Covid-19 pandemic.

#### **9:30 Weed Supervisor Keith Goens**

Goens met with the Commissioners to give updates on the Weed Department. Spraying has been going well, any extra costs he has incurred are being covered by grants. He has received the insects to help with poison hemlock control and they have been placed. He's been working on state roads and is concentrating on other roads now as well. Mostly everything is on schedule. He is still looking into getting a computer which was previously approved. Discussion was also held on getting a pickup for the Weed Department to share with the Highway Dept. in the winter for snow removal. Some discussion was held on the County West building where his office is currently located with Extension. Rodent control is an issue even with current practices. Other minor moving issues were discussed, lights and switches may have to be moved to accommodate the offices.

#### **10:00 Opening of Sealed Bids**

Sealed Bids were presented by Auditor Korth concerning the county property for sale described as Lot 9, Block 9, Original Plat, Town of Clear Lake, Deuel County, SD. Two sealed bids were brought to the Auditor's Office in the time allowed for bidding and were opened. Both parties were present. Lindsey Hinsvark presented a bid for \$1000 and Denise Biller of Dream Transportation LLC presented a bid for \$2,500. State's Attorney John Knight began the bidding between the two parties for sale of the building. The final bid was held by Lindsey Hinsvark for \$12,000. 3) Homan moved, seconded by DeJong to accept the bid of \$12,000 from Lindsey Hinsvark for the property located at 419 3<sup>rd</sup> Ave S, Clear Lake, SD described as Lot 9, Block 9, Original Plat, Town of Clear Lake, Deuel County, SD. A roll call vote was held Kreutner ay, Homan ay, DeJong ay, Rhody ay, Jaeger ay. Unanimous vote, motion carried. State's Attorney John Knight will take care of the purchase agreement and the closing of the sale.

#### **10:15 Drainage Board/John Vande Weerd (2 Applications)**

4) Rhody moved, seconded by Kreutner to adjourn as County Commission and reconvene as Drainage Board. All voted yes and the motion carried.

John Vande Weerd requested a permit to drain on the S1/2SW1/4 of 2-113-48. Proposed length of the drain is 8500 feet using 5-6" tile. Area affected for drainage will be 50 acres. Adjoining landowners had signed Permission To Drain. 5) Rhody moved, seconded by DeJong to approve and

issue Drainage Permit #D20-23 renewal to John Vande Weerd to drain on above described property. All voted yes and the motion carried.

John Vande Weerd requested another permit to drain on the N1/2NW1/4 of 11-113-48. Proposed length of the drain is 9000 feet using 5-6" tile. Area affected for drainage will be 65 acres. Adjoining landowners had signed Permission To Drain. 6) Kreutner moved, seconded by Rhody to approve and issue Drainage Permit #D20-24 renewal to John Vande Weerd to drain on above described property. All voted yes and the motion carried.

7) DeJong moved, seconded by Rhody to adjourn as Drainage Board and reconvene as County Commission. All voted yes and the motion carried.

#### **10:30 Second Reading Ordinance B2004-01-28A**

The second reading of Ordinance B2004-01-28A was held. The Ordinance Amendment would reclassify property located in NE/14NW/14NE/14 & W 268' N661.47 NE1/4NE1/4 in 28-113-47 from AG Agricultural District to CI Commercial District. No further testimony given. 8) Rhody moved, seconded by DeJong to approve, adopt and publish notice of adoption of Ordinance B2004-01-28A, An Ordinance Entitled, An Ordinance to Amend Article II Section 302 Adopted by Ordinance B2004-01, July 6<sup>th</sup>, 2004, as amended, of the Zoning Ordinance of Deuel County. A roll call vote was held. Kreutner ay, Homan ay, DeJong ay, Rhody ay, Jaeger ay. Unanimous vote. Motion carried.

#### **10:45 Deuel Area Development**

Director Joan Sacrison along with board member Cody Eastman and Mayor Gary Eide met with the Commissioners to discuss the future of Deuel Area Development Inc. (DADi).

Sacrison began by presenting her duties and updates that she has been working on at home since the pandemic in April and May. Growth and changes are still happening in the county. There have been many changes in Clear Lake related to economic development. The biggest focus is the community transit to our area. This would be transit between Watertown, Brookings, and Sioux Falls. There would be a minimum charge of \$20.00 for transit for medical/dental/chiropractic services except for certain conditions related to the elderly. This would be an alternating service available on Tuesday and Thursdays. More information is currently being made available to the public with press releases. She is hoping that this is a good addition to the county. She is hoping for an influx of newcomers that want to come into small rural towns to live. Beautification and community betterment are her focus. Discussion was held on the host of improvements that have been happening within the county.

Cody Eastman presented a job description of duties as Executive Director also as it pertains to going to a full time position. Sacrison is planning a 2021 retirement and they would like to see someone on board to train to become her replacement. Eastman stressed that in the times we are in currently, a full time position is needed for grant research and helping businesses. The City of Clear Lake is willing to donate \$35,000 for a 3 year commitment for a full time person. Eastman requested support from the County and explained the dollars come back to the community. Commissioner Rhody asked who funds the health insurance and retirement for a full time position. Eastman stated funding would have to cover health insurance, etc. and be worked out between County and City. Commissioner Jaeger stated that Deuel is mostly an ag community and he questioned if Deuel Area Ag Development was any part of this. Ag and urban ideas often mesh together. Eastman stated that this would be a streamlined vision to encompass many avenues.

Homan asked if other communities are involved. They have strong support from Toronto, but there are many other communities in Deuel. At the State level economic development has a large turnover. The Governor's Office stated 68 Minnesota businesses expressed interest in relocating to SD. Eastman stated he believes economic development will be growing in this state and it's important for Deuel to be on top of that. Discussion was held on how the pandemic will be changing the rural communities with technology, etc. Eastman feels there is much to offer in this area. Eastman wants to know what does the Board need to make the decision about this position. He wants the county to consider it in the 2021 budget.

Mayor Gary Eide spoke in favor of a full time economic development position. He concurred that the rural areas will be growing. He spoke of Wildlife Estates that are prepared for people who need a place to live immediately. He feels that Clear Lake needs to be fully prepared for companies coming in, smaller companies bringing in 8-10 jobs as to not be in competition with larger communities along with housing availability. Eide stressed a full time position will bring qualified applicants rather than part time. Eide represents his city but fully supports other communities and the ag community. The city just had their budget talks and would be willing to support a full time position at \$35,000. He feels that as long as we have availability of housing and other benefits this county will grow. He feels visibility is important for a DADi office. He would like to see the County contribute more than the current \$15,000 that is currently in place. Eide wants this to be considered very seriously and as a city leader is looking to partner to get a full time position for economic development. He feels time is of the essence.

#### **11:00 Emergency Manager Sheila Monnier**

Monnier met with the commissioners to discuss several items related to her department and give updates.

Monnier presented information about Incidence Management Assistance Team (IMAT). This State team is called upon when a crisis occurs. They assist all EOCs across the state and offer specialized training. 9) DeJong moved, seconded by Kreutner to sign the membership application for Monnier to be a part of the State IMAT program. All voted yes and motion carried.

Discussion was held on the Local Emergency Management Performance Grant or LEMPG. (LEMPG replaced SLA). She will have all the paperwork in order and the agreement by the end of the month to continue the participation with the State. The State matches funds for EM and she feels it is important to continue the agreement.

Monnier mentioned the EM conference in September in Spearfish and she will decide on travel in light of the pandemic. The Covid 19 testing and the pandemic was discussed as well as future travel concerns.

Continuity of Operations Training will be held Sept. 22-23 through Zoom. She feels it is very good training in thinking outside the box on coming up with solutions for the County and strongly suggests someone from the Board and any other employees should be a part of this training.

Discussion was held on the 211 program that went live July 1<sup>st</sup> as a helpline. They offer many referrals on many different subjects but their main focus is mental health.

#### **11:15 State's Attorney John Knight**

State's Attorney John Knight had several topics to discuss with the Commissioners.

Auditor Korth inquired on behalf of some of the employees concerning a Covid-19 situation. There are currently (2) Deuel County employees who have scheduled vacation trips, scheduled and paid for prior to the pandemic. These trips happen within the next few months. These employees are going to areas where there is heavy Covid-19 presence. What is the protocol on these employees returning back to work? If there is a quarantine time, will the employee be required to use their own sick leave. Discussion was held if an employee leaves the County within a certain mile radius for a personal vacation, they will be required to be quarantined for 14 days upon return and will need to use their own sick leave or vacation. Deuel County intends on following CDC Guidelines and South Dakota Public Health recommendations and a policy will be forthcoming by next meeting.

A new resolution for discretionary formula which meets the requirements of HB1259 passed by the South Dakota legislature was recommended after lengthy discussion. 10) Kreutner moved, seconded by Rhody to approve and sign the Resolution "Deuel County Resolution No. 20-20 Discretionary Formula SDCL 10-6-35.2" A roll call vote was held. Kreutner ay, Homan ay, DeJong ay, Rhody ay, Jaeger ay. Unanimous vote. Motion carried.

**Deuel County Resolution No. 20-20**  
**Discretionary Formula SDCL 10-6-35.2**

WHEREAS, the County of Deuel County, State of South Dakota, has deemed it in the best interest of the County to adopt a Resolution implementing a Discretionary Formula for the reduced taxation of new structures and additions and partially constructed structures pursuant to SDCL 10-6-35.2. as amended effective July 1, 2020.

NOW, THEREFORE, BE IT RESOLVED, that effective July 2, 2020, the following properties shall be, and hereby are, specifically classified for the purpose of taxation pursuant to SDCL § 10-6-35.2:

Any new industrial or commercial structure, or any addition, renovation, or reconstruction to an existing structure, located within a designated urban renewal area as defined in SDCL § 11-8-4, if the new structure, addition, renovation, or reconstruction has a full and true value of thirty thousand dollars or more (SDCL § 10-6-35.2(1));

Any new industrial structure, including a power generation facility, or an addition to an existing structure, if the new structure or addition has a full and true value of thirty thousand dollars or more (SDCL § 10-6-35.2(2));

Any new nonresidential agricultural structure, or any addition to an existing structure, if the new structure or addition has a full and true value of thirty thousand dollars or more (SDCL § 10-6-35.2(3));

Any new commercial structure, or any addition to an existing structure, except a commercial residential structure as described in SDCL § 10-6-35.2(5) if the new structure or addition has a full and true value of thirty thousand dollars or more (SDCL § 10-6-35.2(4));

Any new commercial residential structure, or addition to an existing structure, containing four or more units, if the new structure or addition has a full and true value of thirty thousand dollars or more (SDCL § 10-6-35.2(5));

**Any commercial, industrial, or nonresidential agricultural property which increases more than thirty thousand dollars in full and true value as a result of reconstruction or renovation of the structure (SDCL § 10-6-35.2(8)); and be it**

FURTHER RESOLVED, that any structure classified pursuant to this Resolution shall, following construction, initially be valued for taxation purposes in the usual manner, and that value shall be referred to in this Resolution as the "Pre-Adjustment Value"; and be it

FURTHER RESOLVED, that the assessed value to be used for tax purposes of any structure classified pursuant to this Resolution shall, following construction, be calculated as follows:

- a. For the first tax year following construction, 20% of the Pre-Adjustment Value;
- b. For the second tax year the following construction, 40 % of the Pre-Adjustment Value;
- c. For the third tax year following construction, 60 % of the Pre-Adjustment Value;
- d. For the fourth tax year following construction, 80 % of the Pre-Adjustment Value;
- e. For the fifth tax year following construction, 100 % of the Pre-Adjustment Value;

and be it

FURTHER RESOLVED, that the Board of County Commissioners may, if requested by the owner of any of the above described property, not apply the above formula, in which case the full assessment shall be made without application of the formula. In waiving this formula for the structure of one owner, the Board of County Commissioners is not prohibited from applying the formula for subsequent new structures by that owner; and be it

FURTHER RESOLVED, that for purpose of this Resolution, the assessed valuation during any of the five years may not be less than the assessed valuation of the property year preceding the first year of the tax years following construction; and be it

FURTHER RESOLVED, that any structure that is partially constructed on the assessment date may be valued for tax purposes pursuant to this Resolution and the valuation may not be less than the assessed valuation of the property in the year preceding the beginning of construction; and be it

FUTHER RESOLVED, that following the five-year period under this section, the property shall be assessed at the same percentage as is all other properly for tax purposes.

**COUNTY RESOLUTION #20-21**  
**A RESOLUTION AUTHORIZING THE EXECUTION OF**  
**CONTRACTUAL DOCUMENTS WITH THE STATE OF SOUTH DAKOTA FOR THE RECEIPT**  
**OF CARES ACT FUNDS TO ADDRESS THE COVID-19 PUBLIC HEALTH CRISIS**

**WHEREAS**, pursuant to section 5001 of the Coronavirus Aid, Relief, and Economic Security Act, Pub. L. No. 116-136, div. A, Title V (March 27, 2020) (the "CARES Act"), the State of South Dakota has received federal funds that may only be used to cover costs that: (a) are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19); (b) were not accounted for in the budget most recently approved as of March 27, 2020, for the State of South Dakota; and (c) were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020; and

**WHEREAS**, Deuel County acknowledges that the State of South Dakota, in its sole discretion, may retain full use of these funds for the purposes delineated in the CARES Act; and

**WHEREAS**, Deuel County acknowledges that in order to provide financial assistance to counties and municipalities in South Dakota, the State of South Dakota, in its sole discretion may allocate CARES Act funds Act on a statewide basis to reimburse counties and municipalities as delineated herein; and

**WHEREAS**, Deuel County seeks funding to reimburse eligible expenditures incurred due to the public health emergency with respect to COVID-19; and

**WHEREAS**, Deuel County acknowledges that any request for reimbursement of expenditures will only be for expenditures that were not accounted for in the budget for Deuel County most recently approved as of March 27, 2020; and

**WHEREAS**, Deuel County acknowledges that it will only seek reimbursement for costs incurred during the period that begins on March 1, 2020, and ends on December 30, 2020;

**NOW, THEREFORE, BE IT RESOLVED** by the County Commission of Deuel County that the chairman of the Deuel County Commission may execute any and all documents as required by the State in order to receive CARES Act funds.

It is further

**RESOLVED** that any request for reimbursement will be only for those costs authorized by the State that: (1) Are necessary expenditures incurred due to the public health emergency with respect to COVID-19; (2) Were not accounted for in the County budget most recently approved as of March 27, 2020; and (3) Were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

It is further

**RESOLVED** that the County will not request reimbursement from the State under the CARES Act for costs for which the County previously received reimbursement, or for which the County has a reimbursement request pending before another source.

Tax revenues from the wind towers in the future were discussed in regards to the 2021 budget.

#### **Health Nurse Contract/Budget 2021/Part-time Human Resource Position**

A handful of other counties do utilize an HR individual. Knight thought SDPAA would be a great resource for issues like these. Knight thought in governmental structure it seems unclear who oversees department heads under these circumstances and it is worth investigating. Many larger counties need an HR department and smaller counties can benefit from this as well. This will be examined and discussed in future meetings.
